## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into by and between:

**Irian National High School**, a public school, located at Purok 3, Irian, Naguiliian Road, Baguio City, represented in this instance by **its school principal, Ms. Grace Domingo**,

-- and --

**Daesung Academy of the Cordilleras, Inc.**, a private educational center for studies on English Education, created in pursuant to the laws of the Philippines, with business address at # 001 BMI Compound, Purok 4, Irian, Baguio City, hereinafter referred to as A&J e-Edu Eco Campus, represented by **its Academic Head, Mr. Ryan P. Ballinaway**,

-- WITNESSETH --

That **Irian National High School** and **A&J e-Edu Eco Campus** agree to a consortium/partnership (Language Exchange Program) as part of the school's local linkages for the International Language Department effective upon signing of this Memorandum of Agreement and in the future.

Specifically, the parties hereby agree, as follows, that:

1. List of student enrollees are to be forwarded to Irian National High School for Language Exchange program;
2. Student enrollees must be a holder of proper visa and whose stay must be regularly updated by A&J e-Edu Eco Campus;
3. A Faculty and student exchange Program concerning Language Exchange is a part and parcel of this MOA; and
4. The obligations and/or contributions of the parties in the administration of the course are hereby set forth as follows:
5. That the immersion or experiential teaching program will not interfere with the regular classes of INHS students and will follow the SPFL lesson flow and indicated class schedules;
6. That A&J will also support SPFL-Japanese at INHS through mentorship, program development assistance, and participation as invited judges in activities when requested;
7. That the MOA will formally cover SY 2025-2026 and remain effective for three (3) years, unless renewed or terminated by mutual agreement.

**Irian National High School shall:**

1. Act primarily as a main partner to supervise, monitor and assure complete compliance of student requirement/s to his/her desired Language exchange program applied for;
2. A supervision of student applicants shall be done by the Program Coordinator;
3. Student qualifiers recommended by A&J e-Edu Eco campus Coordinator shall be entitled to appropriate certificate of recognition signed and filed by Irian National High School representative;
4. Award to all recipients of the program who will satisfactorily complete the language exchange course requirements, or upon satisfaction of existing regulations prescribed by A&J e-Edu Eco Campus and Irian National High School.
5. Ensure that the immersion or experiential teaching program for foreign language will not interfere with the regular classes of INHS students;
6. Require that A&J follow the Special Program in Foreign Language (SPFL-Japanese) lesson flow and curriculum for all lessons taught under the program;
7. Ensure that the immersion program is conducted strictly within the indicated SPFL class schedules.
